The final payment should be made on or before the 05th of October 2024. Failure to make the final payment before the deadline participation on time will result in forfeiting your participation and losing your 25% deposit. Once we receive your registration form, we will provide you with the guidelines on the next action to ensure you have all that you need to complete planning for your participation.
